

## **ACR-Linked Platforms**

ACR-Linked Platforms are external marketplaces approved by ACR for specific activities (e.g., operating an exchange platform, hosting auctions, operating a retail aggregator marketplace). The ACR Registry is central to carbon credit integrity and transparency around projects and credit retirements. ACR partners with, and explicitly permissions, external marketplaces to ensure there is no double selling or double counting of carbon credits. Through the platforms listed below, ACR Registry Account Holders can place their ACR-issued credits in front of global credit buyers and increase market liquidity.
